Principles to be followed for conduct of +3 6th Semester Examinations 2020 (2017-Regular & 2016 –Back Admission Batch).

1. The UG Final Semester Examination (Arts/Science/Commerce) will be held through O.M.R. sheet in physical mode.
2. The question pattern will be objective with 4 multiple choices.
3. Each question carries 02 marks/ There is NO NEGATIVE MARK.
4. The right answer will be rounded in Black Ball Point Pen in box provided in the OMR.
5. The Practical Examination will be conducted through online mode by the college and mark will be uploaded in UUEMS.
6. Only Internal examiner will conduct the Practical.
7. Those who have not conducted the Internal Examinations of above semester, they are requested to conduct the examination online through an assignment and upload the mark in UUEMS portal **before 20th Sept.2020**.
8. The sanitization work of the college examination hall will be completed before the examination date.
9. The question booklet and OMR sheet will be distributed before the date of examination.
10. **If a student wants to attend the examination in his/her nearby colleges to place of residence then he/she should apply to his/her parent college principal for centre change. Once centre change is allowed, he/she will attend the examination at his/her allotted centre and he/she will put his parent college Roll No. in the OMR Sheet.**
11. The students interested to change their centre of examination must apply to the Principals of their parent colleges in this regard within **14.09.2020** and the Principals are requested to send the list of these students to DDCE/UUeMS **positively by 15.09.2020** in **excel format** with Roll No., Name and Name of the Examination centre applied for.
12. The model OMR sheet will be issued to the college and will be uploaded in the website for information of the students.
13. Further, while conducting the above examinations, it is impressed upon all concerned to ensure strict adherence to the following instructions in light of the advisories/guidelines circulated by the Central Govt./State Govt. on account of COVID-19 pandemic:
 - a. Preventive measures like use of hand wash/sanitizer, compulsory use of face mask, maintaining social distancing, regular disinfection etc. are to be undertaken scrupulously while conducting the Examinations.
 - b. There should not be over-crowding of students and staff members during examinations. Taking the social distancing into account, the sitting plan is to be scheduled by the authority.
 - c. Students must be informed about the examination schedule and they may be instructed to come with face mask and their own water bottle and hand sanitizer.
 - d. Principals are requested to keep requisite number of Thermal Scanner (s) as per need, out of Development Fund of their colleges following due procedure for scanning of body temperature of the examinees and invigilators before entering into the examination centre.
 - e. All classrooms/laboratories must be disinfected before the commencement of examination.
